OLT Offshore LNG Toscana Spa developed and implemented the regasification Terminal "FSRU TOSCANA". OLT is the owner and the manager of the Terminal. The Terminal is located at 22 km offshore the Tuscan coast and it is connected to mainland by a 30 Km approximately of pipeline which is used to send natural gas to the Italian national grid.

The regasification Terminal "FSRU TOSCANA" is one of the most important projects of national interest in the gas supply sector and it helps the development and autonomy of the Italian energy system. The project consisted in converting the gas tanker "Golar Frost" into a Floating Regasification Terminal which reconverts the Liquefied Natural Gas (LNG) received from other gas tankers in its original gas status.

The HSEQ (Health, Safety, Environmental and Quality) policy of **OLT Offshore LNG Toscana Spa** outlines an accurate picture of reference about health, safety, environment and social accountability promoting dialogue with all stakeholders, are they internal or external.

- Improve the company management organization by clearly defining the levels of responsibility and by improving the participation of all the personnel;

- Monitor continuously the internal and outsourcing processes by awakening people of all levels to health, safety, environmental and social accountability aspects;
- Clearly communicate company's HSE principle to all stakeholders by open and impartial communications.

In order to perform the above mentioned commitments, **OLT Offshore LNG Toscana Spa** adopts an Integrated Management System according to the following Standards: UNI EN ISO 9001, UNI EN ISO 14001, BS-OHSAS 18001 and SA 8000. OLT involves all staff in the implementation of the requirements provided by these Standards for a continuous company improvement.

For a continuous company improvement, OLT Top Management defines targets measuring the results to evaluate the validity and effectiveness of the company's Integrated Management System providing suitable means and resources.

ENVIRONMENT

OLT's business is basically based on environmental protection. OLT contributes to climate protection by evaluating the important aspects of its business activity reducing their relevant environmental impacts. In particular, company commits itself to:

- Reduce significantly, when it is possible from a technical and an economic point of view, its own air emissions through continuous improvement processes and prevention strategies;
- Not exceed the limits of water discharge and, when it is possible, purify the water drains before discharging in the water tanks;
- Avoid damaging the marine ecosystem;
- Make always the maximum use of the energy through measured saving programs;
- Reduce the consumption of pollution fuels optimizing the production process where they are used.

SAFETY

This policy, together with the major accident hazards prevention policy, is the guiding principle of the European Directives 96/82/CE (Legislative Decree 105/2015) which affirms that the safe functioning of the plant is guaranteed by the implementation of the company or the outsourcer's management criteria. They should be integrated with targets focused to protect the worker's health and with the equipment required by the environmental Legislative Decree 152/2006 and its modifications.

OLT Offshore LNG Toscana S.p.A being the FSRU's Manager, in accordance with Legislative Decrees 105/15 and 152/2006, promotes the cooperation with the regulatory and competent authorities to encourage the exchange of information, the development of common emergency procedures and to optimize the controls to carry out. Company considers the behaviour of its collaborators and outsourcers towards the safety and the mayor accident prevention a primary aspect to evaluate their professionality.

As per the naval characteristic of the Terminal and for the presence of a SHIPOWNER (outsourcer) to whom the operating management is entrusted, Company controls continuously the management system applied by the

- Protect the environment and the sea from any kind of pollution by an active environmental responsibility and by continuously promoting the reduction of environmental negative effects.

Coherently with its company policies which aim to protect legality and ethic in the commercial relationships with employees and collaborators, **OLT Offshore LNG Toscana S.p.A** has implemented a management model to prevent any unfair behaviour while carrying out its business activities. OLT applies a code of ethics and the model 231 to reduce the risk to violate what is provided in the Legislative Decree 231/2001.
