

**FIRST DEMAND LETTER OF LETTER OF GUARANTEE  
TO BE ISSUED TO THE BENEFICIARY**

Whereas:

- The company ..... with registered office in..... Tax Code ..... VAT reg. no. .... parent company and/or part of the Client's Group, as defined in the Access Code (**Guarantor**), of the Company .....(**Applicant**)..... with registered office in .....Tax Code.....VAT Reg. no.....
- The Company .....(Applicant)..... with registered office in ..... Tax Code ..... VAT Reg. no. .... intends to participate in the "Procedure for the assignment of the integrated regasification and storage service under Article 1 of the Ministerial Decree dated 7 December 2016" (**Procedure**);
- OLT Offshore LNG Toscana SpA, in its capacity as Operating Company of the Terminal and by virtue of the provisions of Article 2 h) of the Procedure, requires together with the capacity application a first demand letter of guarantee, the amount of which is € 50,000.

The above being stated

- 1) The Guarantor declares that it holds the required credit rating as indicated in Clause 3.1.1.1 (a)(i) of the Access Code.
- 2) The Guarantor irrevocably undertakes to immediately pay OLT Offshore LNG Toscana SpA, on simple written demand and by written request and without any evidence or justification, without exception and without any prior communication, notice, formal notice or claim against the Company .....(Applicant)....., the sum of 50,000 euros (Euro fifty thousand/00).
- 3) The guarantee may be enforced several times, until the maximum amount referred to above has been paid..
- 4) The Guarantor declares that the provisions of Articles 1955 and 1957 of the Italian Civil Code do not apply to this guarantee and in any case waives any right to exercise such an option.
- 5) This guarantee ensures the fulfilment of all the obligations undertaken by the Company .....(Applicant)..... with the submission of the capacity request provided for by the Procedure by either by way of fees or by way of damages or compensation, and will be valid from the date of issue and will be redeemed with the signing respectively of the Regasification Contract of .....(Applicant).....with OLT Offshore LNG Toscana SpA, the Storage Contract of .....(Applicant).....with Stogit SpA and the Service Contract (Annex 1 to the Procedure) with OLT Offshore LNG Toscana SpA and Stogit SpA or of the waiver option communication.
- 6) Any disputes regarding the interpretation, validity, effectiveness and enforcement of this guarantee shall be referred exclusively to the Court of Milan.
