**DECLARATION IN LIEU OF AFFIDAVIT

With reference to the “**PROCEDURE FOR THE ASSIGNMENT OF THE REGASIFICATION AND STORAGE BUNDLED SERVICE UNDER ARTICLE 1 OF THE MINISTERIAL DECREE DATED 29 MAY 2017**” published on May 30th, 2017 on the website of OLT Offshore LNG Toscana S.p.A. DECLARES THAT¹

- 1 – the Representative and the Represented Parties are not subject to bankruptcy or liquidation proceedings or actions by OLT and/or STOGIT for the recovery of credit at the time of submitting the bid²;
- 2 – the Represented Parties, either directly or through the Representative, are users of Snam Rete Gas S.p.A. transportation service³;
- 3 – the Represented Parties, either directly or through the Representative, have, where known, LNG carriers authorized by OLT for unloading at the Terminal⁴;
- 4 – the Represented Parties, either directly or through the Representative, hold a contract with STOGIT for the uniform storage service as specified in article 3 point (B) of the Procedure⁵;
- 5 – only if applicable, where the Represented parties have consumption sites in country other than Italy, the Represented parties have either directly or through the Representative a transportation contract valid for an exit point from the Italian gas transportation grid interconnected to a foreign gas transportation grid;⁶

AND/OR THE REPRESENTATIVE IN THE NAME AND ON BEHALF OF THE REPRESENTED PARTIES UNDERTAKES ⁸1 – that the Representative and the Represented Parties are not subject to bankruptcy or liquidation proceedings or actions by OLT and/or STOGIT for the recovery of credit at the time of submitting the bid⁹

- 2 – that the Represented Parties, either directly or through the Representative, are qualified by user of Snam Rete Gas transportation service within the 1st day of the month the first delivery at the Terminal is scheduled for¹⁰;
- 3 – that the Represented Parties, either directly or through the Representative, have LNG carriers authorized by OLT for unloading at the Terminal to carry out the unloading by means of an LNG carrier compatible with the Terminal's specifications which has to be authorized according to the procedures provided for and defined by the Terminal, with the risk that the authorizing procedures may not be successful lying with requesting entity¹¹;
- 4 – that the Represented Parties, directly or through the Representative, sign a contract with STOGIT for the uniform storage service before the stipulation of the Contract for a regasification and storage bundled service as specified in article 3 point (B) of the Procedure¹²;
- 5 - only if applicable, where the Represented Parties have consumption sites in country other than Italy, to have directly or through the Representative a transportation contract valid for an exit point from the Italian gas transportation grid interconnected to a foreign gas transportation grid;¹³
- 6 – to sign LNG import contracts or agreements aimed at making the quantity of LNG for the import of which the capacity is requested¹⁴

The Representative undertakes that the Represented Parties, either directly or through the Representative, signs a SLOT Capacity Contract for the regasification capacity for the purpose of the regasification and storage bundled service in accordance with the Article 5.1 of the Procedure.
